

TERMINOLOGY

LET'S DEFINE OUR TERMS...

Theism - Belief in the existence of a personal God, who is the creator and sustainer of the universe, and who is understood in a manner consonant with both Greek philosophical and Judeo-Christian thought (i.e. God as uncreated, eternal, all-knowing, all-powerful, etc.)

Theoretical Agnosticism – The belief that the existence of such a God is unknowable in principle (or at least unknowable with any useful degree of certitude)

Practical Agnosticism - A personal suspension of belief regarding the existence of God based on insufficient evidence or reflection (in other words: "I don't know")

Atheism - Denial of the existence of God (as understood by the theist)

TWO SUB-CATEGORIES OF "THEISM"

Deism - A religious belief holding that God created the universe and established rationally comprehensible moral and natural laws but does not intervene in human affairs through miracles or supernatural revelation.

Revealed Religion - A religious belief holding the God not only created the universe and established rationally comprehensible moral and natural laws but has and does intervene within his creation, especially by communicating himself and the designs of his will to human creatures by means of Divine Revelation


The SCOPE of these arguments is simply to defend basic theistic belief...not to argue for the whole truth of the Catholic faith.

Evolution only impacts arguments for theism when using primitive "design arguments" like William Paley's famous WATCHMAKER ARGUMENT...

(which almost no one uses today)


William Paley (1743 – 1805)

"For my part, I take my stand in human anatomy [where there appears] the necessity, in each particular case, of an intelligent designing mind for the contriving and determining of the forms which organized bodies bear"

We will be using real arguments organized in logical structure. They will be of two kinds: - Abductive arguments - Deductive arguments

The quality of evidence is not to be judged solely by how it is received.

Faith is a gift from God, but that does not mean that arguments for God's existence are futile.



Vatican I (1869-1870)

"If anyone says that the one, true God, our creator and lord, cannot be known with certainty from the things that have been made, by the natural light of human reason: let him be anathema."

(Vatican I: Dei Filius, chapter 2)

"Scientism" is badly mistaken

FORMS OF "SCIENTICISM" "The Scientific Method has been so amazingly successful at making all WEAK FORM sorts of discoveries about the natural world. Surely it would have been able to prove God's existence by now." STRONG FORM "The Scientific Method is the only way to arrive at knowledge/truth"

CRITIQUES OF "SCIENTISM"

WEAK FORM	"The Scientific Method has been so amazingly successful at making all sorts of discoveries about the natural world. Surely it would have been able to prove God's existence by now." Response: This is a clear category error, as if we believe God to be a material object within the world. Example: Metal-detector analogy and Lamppost analogy
STRONG FORM	"The Scientific Method is the only way to arrive at knowledge/truth" Response: This is self-referentially false. It is also manifestly not true (moral truths, first principles of philosophy, etc.). The scientific method itself relies on fundamental truth claims about the natural world that are not subject to empirical verification.

God, as classically understood, is not a "being among beings."
